The State Council of the Interstate Compact for Adult Offender Supervision met on July 26, 2019 to discuss rules that will be presented for approval before the National Interstate Compact Administrators at their annual meeting in September. Compact Administrator Murphy recognized ACC Staff Attorney Amber Schubert to present and explain each proposed rule amendment, and call for a discussion and vote on each.

The rules presented and results are as follows:

- 1.101 Definition of "Reside" & 2.110(a) Transfer of Offenders under this compact. ICAOS is withdrawing, so no need to vote.
- 1.101 Revise Definition of "Abscond" & 4.109 Absconding Violation. Motion to oppose by Kevin Murphy; second by Whitney Gass. Motion passed.
- 1.101 Revise Definition of "Sex Offender" & 3.101-3 Transfer of supervision of sex offenders; investigation; additional documents & reporting instructions; 3.107 Transfer Request. Motion to oppose by Buddy Chadick; second by Dr. Byers. Motion passed.
- 1.101 Remove Definition of "Victim-Sensitive" & "Temporary Travel Permit", 3.108 Victims' right to be heard & comment; 3.108-1 Victim Notification & requests for offender information; 3.110 Travel Permits; 4.111 Returning Offenders. Motion to approve by Buddy Chadick; second by Dubs Byers. Motion passed.
- 3.101-1(a) & (a)(2)-Mandatory reporting instructions and transfers of military, families of military, family members employed, employment transfer, and veterans for medical or mental health services. Motion to approve Whitney Gass; second by Buddy Chadick. Motion passed.

- 3101-1(a)(5)(A)-Mandatory reporting instructions and transfers of military, families of military, family members employed, employment transfer, and veterans for medical or mental health services. Motion to approve by Buddy Chadick; second Bobby Glover. Motion passed.
- Rule 3.103(a)-Reporting instructions; offender living in the receiving state at the time of sentencing or after disposition of a ~~violation or~~ revocation proceeding by a court, paroling authority or other criminal justice agency following the retaking of the offender from the receiving state. Motion to approve by John Felts; second by Buddy Chadick. Motion passed.
- 4.106-Progress Reports on offender compliance and non-compliance. Motion to approve by John Felts; second by Whitney Gass. Motion passed.
- 4.109(c)(3)-Violation report(s) requiring retaking. Motion to pass by Cory Cox; second by Dubs Byers. Motion passed.
- 4.111(a)-Offenders returning to the sending state. Motion to pass by Buddy Chadick; second by John Felts. Motion passed.
- 5.101-Discretionary retaking by the sending state. Motion to pass by Buddy Chadick; second by John Felts. Motion passed.
- 5.103(d)-Offender behavior requiring retaking. Motion to pass by Buddy Chadick; second by John Felts. Motion passed.
- 5.103-1(a)-Mandatory retaking for offenders who abscond. Motion to vote against unless number of days is changed from 15 to 45 days by Dubs Byers; second by Kevin Murphy. Motion passed.

In other business, Amber Shubert reviewed Act 134 of 2019 with Council Members.
