

Remember:

1. Graduated Sanctions will not be used for Sex Offenders (with any prior sex offense conviction), but will include Lifers
2. Violations of Restraining Orders and Failure to Report as instructed upon release (with no verifiable excuse) will be sent directly to the Board via a preliminary hearing in custody. There are no intermediate sanctions or interventions for these parolees.
4. Graduated Sanctions will not be used for Absconders. Follow traditional response.
5. If a parolee fails to show for a street hearing, the parole officer will investigate, and if there is no acceptable explanation, detain the offender and proceed with a hearing in custody.

Mitigating Factors:

In addition to offender risk level and violation severity, responses to violations need to consider behavior while on parole (including compliance with conditions), prior sanctions on this parole (including warning/final warning status), and other aggravating or mitigating factors. In addition to applying sanctions that are proportional to the violation, appropriate interventions should be employed that are designed to change the offender's behavior.
