#### Call to Order

Chair M. Pevey (WA) called the meeting to order at 12:55 pm ET, twelve out of thirteen members were present; a quorum was established.

# **Approval of Agenda and Minutes**

Commissioner D. Littler (AZ) moved to approve the agenda as presented. Commissioner B. Mamizuka (HI) seconded. Agenda approved.

#### **Discussion**

*State Updates:* Region members gave state updates that encompassed staffing and retention issues, extraditions, transports, remote hearings, alternatives to incarceration, and the need to conduct more in-state training.

#### **Old Business**

Colorado's Advisory Opinion Request: As Chair M. Pevey recognized Colorado, he reminded the region this is a rule making year. D. Whitefield initiated the discussion noting the Executive Committee decided not to provide an advisory opinion as requested by Colorado, although many states struggle complying with the requirement to arrest once probable cause is established in accordance with Rule 5.108(f). D. Littler (AZ) stated compliance with Rule 5.108 (f) has been an issue historically for many states and perhaps the region should consider a rule amendment to change 'shall' to 'may.'

*Tribal Best Practices update:* Chair M. Pevey tabled this discussion for next region meeting.

#### **New Business**

*Nomination of Officers:* 

M. Pevey indicated the Midwest has nominated M. Hudson (IN) for Chair and the East nominated G. Roberge (CT) for Treasurer requesting if the West Region has additional nominations.
