Welcome and Introductions

Andrew Zavaras

Presenter

- Manager Zavaras welcomed all participants & guests to the meeting; introduced himself & the DCAs; explained the new format for CO's state council (how it is now structured & why); asked DCA Cribari to conduct roll call, which was completed & he noted quorum established for voting members.
- Guests & Video Presentation
 - Two videos were presented: these videos gave some insight into the crime against Peyton Tuthill, her family & Pat Tuthill's history with Victim's Advocacy & ICAOS involvement.

> Pat Tuthill, ICAOS Victims Representative & Peyton Tuthill Foundation, Founder

Mrs. Tuthill described her involvement and role as a victim's representative for the ICAOS national office; she shared her daughter's story as a victim of a heinous crime & how, ultimately, that lead to her involvement in advocating for all states to participate in/adhere to ICAOS standards. She emphasized how important our roles as compact members are & how she further supports the necessity of representing victims through her continued presence in speaking to inmates & various justice organizations, advocating for victims & continued work through the Peyton Tuthill Foundation.

Ashley Lippert thanked the group for being asked to participate today; emphasized the importance of state councils & gave insight as to their role; state councils serve as an advocate to the Compacts in CO, help seek resources & improve CO's operations & resolving disputes among other stake holders in CO; Highlighted some of Colorado's data viewed by the national office (various dashboard info), changes due to operations impacted/continue to be impacted by COVID19 such as transports and current projects the national office is working on (preparing for the 20th anniversary ABM & connections & alerts through NCIC with assistance of FBI).

• Commissioner Zavaras asked voting members if there was a motion regarding the bylaws that had been presented to the group: Director Tapia made a move to approve the bylaws as drafted; member Kissell seconded; Commissioner Zavaras acknowledged moved & seconded that the bylaws be approved & adopted by the State Council. Before the vote, Zavaras asked if there was any discussion; hearing none, the question before the council was for the approval & adoption of the bylaws

➢ Ratification

- 0 Bylaws adopted on this date (10.29.2021) with all present voting members verbally acknowledging 'ave' in favour of the adoption; no persons voting 'nay' in opposition
- * Remote sentencing
 - Referenced white paper from the national office pertaining to remote sentencing (which developed due 0 to COVID 19 changes); issue was with sex offenders being prohibited from returning to the receiving state pending sentencing; white paper essentially addressed this issue;
- **ICAOS Rule Amendments & ICOTS Enhancements** *
 - DCA Cribari discussed 3 primary changes (hand-out): 1.101 (definition of 'resident' revised), 5.108 0 (clarification that PC must be established prior to retaking an offender on a violation that is actually revocable in the receiving state), Warrant timeframes (changes in rules & technical changes in ICOTS)

* **Retaking Fund**

o A Colorado House bill went into effect July 2012 which allows for probation to collect an application fee for those applying for an interstate transfer; these fees go into a fund to help sheriff's offices with retaking expenses (probation only); DCA Whitefield wanted to remind previous members & educate new members about this fund/ availability as some sheriff's offices may not recall that this resource is available to them

* Roundtable

- Director Tapia just wanted to acknowledge the Colorado team for keeping our compliance rates (with \circ the national office) high, especially with the challenges presented by the pandemic.
