## Call to Order

Chair T. Link (AK) called the meeting to order at 2:50 pm ET, eleven out of thirteen members were present; a quorum was established.

### Approval of Agenda and Minutes

Commissioner D. Littler (AZ) moved to approve the agenda as presented. Commissioner M. Pevey (WA) seconded. Agenda approved.

Commissioner M. Pevey (WA) moved to approve the minutes from September 19, 2023 as drafted. Commissioner A. Zavaras (CO) seconded. Minutes approved.

#### **Discussion**

### 2023 Rule Proposal Amendment 5.108(f)

Chair T. Link inquired if there was any discussion or any questions related to the proposed Rule amendment. Commissioner D. Blanchard (UT) inquired as to whether the proposal had been reported out favorably by the West unanimously in the past. Director Eskridge responded affirmatively.

*State Updates:* Region members gave state updates that encompassed staffing and retention issues, budgetary issues, an increasing emphasis on training, a desire to reinvigorate and use state councils to leverage partners, funding for hardship housing, increasing use of in-person status updates from judges, issues related to decriminalization of substances and conflict between treating addiction as a health issue versus criminal issue, the need to improve incentives to complement sanctions, jail capacity challenges and resulting release policies, the continuing need to educate officers and judges on the need and purpose of the Compact, and challenges with issuing Compact compliant warrants.

### Unsupervised Probation/Bench Supervision/Administrative Probation

Commissioner Mamizuka (HI) inquired as to whether states were seeing an increase in use of unsupervised/administrative probation or bench supervision and whether such cases were being sent through the Compact. Several states responded that if monitoring was not simply monetary in nature, the individual under supervision must be placed on the Compact and that the receiving state may indicate use of the Compact is required due to conditions of supervision. Commissioner D. McDaniel (NV) noted that misdemeanant courts were problematic from that perspective but that they were working to educate and train those officials on ICOTS and the Compact.
