#### Call to Order

Chair T. Hudrlik (MN) called the meeting to order at 8:30 am ET. Executive Director A. Lippert called the roll. Eight voting members were present, a quorum was established.

#### **Approval of Agenda and Minutes**

Commissioner D. McDaniel (NV) moved to approve the agenda as presented. Commissioner C. Moore (GA) seconded. Agenda approved.

## **Discussion**

Review "supervised individual" language changes: In November 2023, the ICAOS Executive Committee unanimously agreed to replace the term 'offender' with 'supervised individual' across the Commission's publications, rules, and official website. This change aims to foster a more person-centered approach while eliminating barriers and biases associated with traditional terminology. It demonstrates the Commission's commitment to evolving practices that align with the values of dignity and respect. The Rules Committee was tasked to revise the ICAOS Rules to reflect the approved language.

The Rules Committee integrated the change into the ICAOS Rules. While 2024 is not a formal rule-making year, the Rules Committee acknowledged the significance of promptly implementing this change. Doing so will ensure that the rules up for consideration next year seamlessly incorporate the language change, and that any forthcoming amendments already reflect the change.

Certain rules required more than a simple replacement of the term "offender" to "supervised individual" and the Rules Committee adjusted the language for readability. The Rules Committee worked to preserve the original meaning of the rule and made no substantive changes, only editorial adjustments (see the attachment).

The committee decided to post the rule proposal package for Commissioner's comments from May 15 until July 1, 2024. The committee will meet in July to review submitted comments and adjust if necessary. The final rule proposal package will be posted on the Commission's website on August 1.

Chair T. Hudrlik (MN) will ask the Executive Committee to amend the 2024 ABM agenda by adding the Public Hearing on Monday, September 9 and an information session on the rule package on Tuesday, September 10. The Commission will vote on the proposed rule package on Wednesday, September 11.

The committee will decide on the effective rule date at its July meeting.
