MEETING MINUTES

The Nevada State Council for Interstate Adult Offender Supervision held a public meeting on December 22, 2021, beginning at 12:01 p.m. PST, at the Nevada DPS Parole and Probation building, 215 E. Bonanza Road, Las Vegas, NV 89101. All meeting were connected via ZOOM teleconference.

1. Call To Order:

The meeting was called to order by the Chair, Commissioner Captain Deborah Dreyer at 12:01 P.M. PST.

2. Roll Call:

Council members present included: Nevada Commissioner Captain Deborah Dreyer; Judge Scott Freeman and District Attorney Eckley Keach. Guests present: Lt. Shannon Serena, Sgt. Sharia Chandler, Sgt. • Since a quorum was not achieved today, we will not be voting, taking any action, or making any motions today. Today's meeting will consist of informal discussion.

3. Meeting Opening

Commissioner Captain Deborah Dreyer opened the meeting with public comment, if anyone from the public, who was attending at either location or via ZOOM, would like to make a comment. No comments were made.

4. Approval of Minutes:

Commissioner Captain Deborah Dreyer stated that there was not a quorum present, there will be no motion to approve Nevada State Council for Interstate Offenders meeting minutes from July 16, 2019. Clark County District Attorney Keach stated he had read over the minutes and had there been quorum he would have approved the minutes and Judge Freeman state he too had reviewed the minutes and would have second the approval of the minutes.

6. Discussion Item:

Lieutenant Serena reviewed the following discussion points.

- Review of the 2021 ICAOS Annual Business Meeting
 - Due to COVID 19, the annual business meeting was conducted virtually in 2021
 - September 21, 2021, through September 29, 2021
 - Agendas consisted of a Commissioner Meeting, Region Meetings and break out training seminars.
 - o 2022 ABM will be in person and is scheduled for September 26-28 in New York, NY
- Summary of the 2021 ICAOS dashboard reports
 - Performance measures are tracked for several key components of timeliness in compact action tasks required to process transfer requests between states and manage caseloads based on an offender's compliance with supervision.
 - Each state must keep a compliance rate of 80% or greater
 - Nevada has performed above the 80% minimum requirement and often times higher than the national averages.
 - Nevada Performance Rates:
 - For the time frame 1/1/2021 through 12/10/2021, NV's performance rates ranged from 82.38% to 98.09% compliant, with an Average Days Overdue on these same performance measures ranging from 0.19 days to 4.98 days.
 - The National average of all states for this period ranged from 89.09% to 97.66% compliant, with an Average Days Overdue rate of 0.06 days to 3.49 days.
 - Nevada Supervision:
 - Between 01/01/21-12/09/21 NV ISC (statewide) supervised 1,193 incoming cases and 1,424 outgoing cases.
 - Between 01/01/21-12/10/21 NV received 896 ISC incoming transfer requests (statewide). NV accepted 67.7% of those for a total of 607 new cases.
 - Between 01/01/21-12/10/21 NV submitted 952 outgoing transfer requests to other states (statewide). Of those 723 were accepted by other states for a 75.9% acceptance rate.
- Review of pertinent items from the ICAOS 2021 Annual Report
 - Nevada paid \$20,056.26 for FY 2022. This represents a onetime 30% reduction in dues from FY 2021 due to the economic crisis caused by the COVID pandemic.
 - The Commission voted for and passed 5 rule amendments and ICOTS enhancements. These changes go into effect on 4/1/2022.
 - Lieutenant Serena will turn the meeting back over to Captain Dreyer

7. Public Comments and Discussion:
