Welcome and Introduction, Joe Winkler

• Joe Winkler, Assistant Secretary of Community Corrections, Chairperson for Florida's State Council of Interstate Adult Offender Supervision

Victims Update, Lisa Kinard

- Victim Services Unit (VSU) serves as a victim's point of contact with other areas of the Department
- Assist victims of crimes committed by offenders in our custody or under our supervision
- Notify victims prior to an inmate release to supervision
- Help victims understand the post-conviction process
 - o Focus on what we CAN do for the victims, that than what we cannot
- Liaison between victims and supervising staff to ensure victims are heard and their rights are upheld
- Ensure victims are considered within the incarceration and supervision processes
- Especially important role for Interstate Compact transfer cases, where the victim may understand the laws in their state but no those in the sending or receiving state
- Serve as the Statewide VINE Administrators for FDC inmates, supervise offenders and all 69 county jails inmates
 - o Provide status change notifications to registered victims

Recap of ABM, Joe Winkler/Tim Strickland

- 09-26-28-22 in NYC
- This year was virtual
- Bylaw Nat District Atty Org is ex officio member
- Rule changes 4-1-22
 - Resident definition changed to 1 yr. prior to the sentencing date or beginning of supv
 - Clarification to PC hearing and tech violations can request if revo likely and admission must be to revocable offense
 - \circ Standardized the time for all warrants issued All 15 business days from date received or failed to return
 - 2 days for field to get notifications
 - 3 to get to court
 - 10 business days to get through court and into NCIC
 - Judge Soud Need to move to technology Ewarrants
 - These SHOULD include current victim information and be flagged as confidential so not printed and released, except for court and SAO.
- ICOTS change for warrant tracking system
 - Dashboard and self-auditing

Travel Request and RFRI, Tim Strickland

- Reviewed the rules on how an offender can qualify for Florida to request reporting instructions
 - Allow an offender to proceed to the receiving state while the transfer request is being investigated
- Reviewed Rules 3.101-1, 3.103 & 3.106
 - Stressed that until the receiving state provides approval for an offender to proceed to their state they must remain in Florida.
 - o A Florida court cannot order the offender to proceed to a receiving state.
- Only Rule 3.103, living in the receiving state at the time of sentencing,
 - Allows for an offender to be able to proceed, except for sex offenders, prior to submission of and approval of a request for reporting instructions

Transfers, Chris Lane

- Reviewed the Interstate Compact Eligibility Guide and reasons for transfers
 - o Reviewed and discussed the requirements for an offender to qualify for transfer
 - Reviewed the reasons/justifications for transfer
 - o Reviewed eligible misdemeanor offense criteria
- Discussion on use of regular hotel for sex offenders

• Discussion on requirement to accept SO who meets mandatory criteria. Judge feels this could be challenged.

Goals, Plans, Training Topics, Angella New

- Reiterated the purpose of the Compact and the State Council (see July minutes)
- Any short-or long-term plans
- Discussions regarding judicial training, specifically in Circuit 04 and an opportunity to provide to a statewide audience at the Circuit Judges Conference

Application Fees, Angella New

- Provided break down of states and their fees and North Carolina notification form
