**A. Rule Change Proposals**

Year 2025 is a rule-making year. The proposed changes are due to persistent issues and concerns with current rules:

- Revocation Definition and Retaking after New Conviction
- Retaking after New Conviction Resulting in Supervision
- Probable Cause Hearings
- Absconders
- Mandatory Reporting Instructions for those living in the receiving state at the time of sentencing or after disposition of a violation or revocation proceeding.

**B. Confirmation of Victim Representative, Rosemarie Albano**

Commissioner Brook Mamizuka has made two requests to the Senate President to calendar the confirmation of Rosemarie Albano as a Victim Representative on the State Council, however, as of this date, no response has been received. On March 16, 2024, Commissioner Brook Mamizuka sent a letter to Governor Josh Green requesting his nomination of Rosemarie Albano subject to confirmation proceedings. As of this date no response has been received.

Assistance will be requested from Chief Justice Mark Recktenwald and Administrative Director of the Courts Rodney Maile to schedule the senate hearing.

**C. Appoint Deputy Compact Administrator Stacey Luke to Cast Votes for Hawaii**

Due to prolonged medical conditions of Commissioner Brook Mamizuka, she was not able to attend the 2024 Annual Business Meeting. Deputy Compact Administrator Stacey Luke was authorized as the designee to cast votes for the state of Hawaii at the 2024 Annual Business Meeting. She has requested to be appointed by the State Council to cast votes on behalf of Hawaii in the absence of the commissioner of Hawaii. Albert Cook moved to approve Deputy Compact Administrator Stacey Luke to cast votes on behalf of the State of Hawaii in the absence of the commissioner of Hawaii. The motion was seconded by Lisa Itomura and unanimously approved.

**D. Renewal of Office of the Prosecuting Attorney of the City and County of Honolulu**

The term will expire on November 6, 2024. Deputy Compact Administrator Stacey Luke asked the Council to renew the term from November 7, 2024 until November 6, 2028. Lisa Itomura moved to renew the term of the Office of the Prosecuting Attorney of the City and County of Honolulu from November 7, 2024 until November 6, 2028. Albert Cook seconded the motion. The motion was unanimously approved.

**E. Training on the Importance of the Compliance of the Interstate Rules**

Deputy Compact Administrator Stacey Luke asked for the Council's assistance in statewide training with defense attorneys, deputy attorney generals, and deputy prosecuting attorneys. She stressed the importance of remaining in compliance with the rules of the compact and continuing to train judges, attorneys, and probation and parole staff. It is important to work together to track the individuals in order to keep victims and the community safe.
