Rule Proposal Year

• This year at the ABM 20 rule proposals will be voted on.

# Following are the significant rule proposals for discussion:

## Revise Definition of "Abscond":

- Expand investigation activities prior to reporting and absconder.
- Create a 30 day "holding period" for the receiving state to keep the ICOTS case open pending apprehension.
- Allows for mutual agreement to forego retaking.
- Ensures due process is afforded prior to retaking.

# Victim's Right to be Heard and Comment:

• Minor revision and clarification that the supervised individual does not "submit" a request to transfer rather a request to transfer is *transmitted* to the receiving state or a *request is made* to return to a sending state.

#### Manner and Degree of Supervision in Receiving States:

• Establishes requirements for documentation/communication and clarifies the receiving state's authority to impose sanctions, ensuring consistency with locally sentenced individuals and reinforming the "treat like your own principle".

## **Annual Due Increases:**

- In FY2024, the Commission increased dues by a standard 5.25% for five years. In FY2029, the standard annual increase reduces to 3%.
- Oregon's FY 2026 dues were \$33,405.52

## **Questions/Discussion:**

**Q:** How will reduced funding affect victim notifications?

**A:** Robyn explained that some counties may need to train frontline staff to assume notification responsibilities if advocate positions are cut.

**Q:** Will the new abscond rule create delays in enforcement?

**A:** Jeremiah clarified that the intent is to create consistency across states; the 30-day window is meant to prevent premature violation reports.

**Q:** What is the process for probation warrants under the new guidelines?

A: Jeremiah noted feasibility varies by county; further review will determine if the 15-day timeline is practical.

**Q:** How will the counties be supported in understanding any new compact procedures?

**A:** Mark stated that onboarding resources, training, and mentorship from experienced members will be provided if new rule proposals pass.

#### **Discussion on Victim Notifications:**

Mark and Robyn reviewed how DOC 400 is used to identify registered victims and ensure they are notified of transfers or retaking actions under the Interstate Compact. They noted that current funding reductions may impact dedicated victim advocate positions, which could shift notification responsibilities to frontline probation staff. Council members raised concerns about maintaining consistency and victim trust. Suggestions included exploring alternative funding, providing standardized training for POs, and strengthening coordination across DOC, the Parole Board, and counties. Jeremiah and Robyn will monitor the funding situation and work with partners to maintain compliance and reliable victim services.

# **Follow-up tasks:**

- Rule Proposal Review: Send out the final list of rules that passed after the annual business meeting to all council members in the next month or so.
- **Victim Notification Process:** Ensure that the victim notification process is compliant despite potential reductions in victim services funding.
- **Rule Proposal Training:** Prepare and conduct training sessions for county partners on the new rule proposals if they pass.
- **State Council Membership:** Reach out to potential new members, including legislative members, to join the State Council.
